"We too often think about roadway deaths as if they are normal, part of life in our times - almost as if we were living through a war."

"[W]e have been bathed in this level of carnage all our lives. And so we're a bit like people who grow up in a place that's experiencing a war, in terms of how normal we think that is."

Dear Secretary Buttigieg,

When Evalene Pyle was killed trying to cross US13 on a bicycle in Dover in 2022, there were no memorials or vigils and barely any news coverage beyond a perfunctory repetition of the police report. Her death was barely remarkable. As in most places in the United States, deaths caused by crashes are regarded by many (most?) Americans as inevitable.

You know they are not. You know that Americans suffer not just 10% or 20% or 30% more traffic fatalities per capita than our advanced country peers but, rather, 300% more (compared to France or Germany) or even 500% more (compared to Norway). The horrifying system we have built - painstakingly and at staggering cost over decades - continues to kill our friends and families every year at a rate which should be a first-order political crisis on our country (but isn't). Not even the fact that crashes are the #2 leading cause of children both in Delaware (like President

Biden's infant daughter) and the U.S has - so far - failed to move traffic safety to the top of the U.S. political agenda.

But even though you are not compelled to act by political clamor, you can nevertheless choose to act and - with the RAISE program - you have been given greater scope to act than previous USDOT secretaries. We ask you to consider the relative merits of a RAISE grant application from the Delaware Department of Transportation to fund the construction of the MLK Boulevard/South Little Creek Road Bicycle and Pedestrian Connector, which is specifically scoped to prevent future tragedies like Evalene Pyle.

Safe infrastructure for cycling serves the needs of people of every socioeconomic background. When we build good cycling infrastructure, more people choose to use a bike. Recent data from both Streetlight Data and the Census Bureau that show cycling growing faster in Delaware since 2019 than almost anyplace else (#3 after only New York and New Jersey in StreetLight's report and #2 after only Rhode Island in the Census Bureau's data) backs that up. So your support for this project will mean more people choosing to make trips using a bicycle in Dover. But that perspective understates the urgency of this specific project because of the high level of poverty in the area. Of the 1,400 households that would be directly served by this project, 99% are located in a Historically Disadvantaged Census Tract and 28% and 79% are classed as being in an Area of Persistent Poverty and/or a DelDOT Equity Focus Area, respectively. In my 13 years at Bike Delaware, I cannot recall another bike/ped project located so specifically in an area whose socioeconomic characteristics are so correlated with a higher percentage of people - like Evalene Pyle - who do not have access to a car for transportation and whose need for safe alternative infrastructure is, literally, a matter of life or death.

Crosswalks and bicycle and pedestrian refuge islands will be installed at the intersections of Bay Road, US13, South Little Creek Road and MLK Boulevard to safe crossing. The path will then connect to an existing pathway on the southern side of MLK Boulevard. This existing pathway is part of the Capital City Trail and other bicycle and pedestrian trail networks that connect to various places within the City of Dover including government buildings, parks, transit center, schools, etc.

For the project's exceptional benefits including health, environmental, economic and community connections, we extend our sincere support for this project and request your positive consideration.
